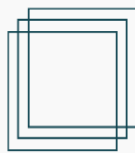

Annotation

Unlike commercial enterprises, the task of accounting for extra-budgetary funds of budgetary institutions is not only to provide information for the purpose of making investment and management decisions, but also to ensure control over the activities of institutions by state bodies. Reforming the budget account is an urgent task in order to ensure the transparency of business activity and increase its efficiency. Now the situation is such that the information in the legally established financial reporting network is not enough for the management of the institution to make informed management decisions and for the founder to control extra-budgetary activities. The current stage of the development of budget accounting of budget organizations includes its two traditional sectors - budget execution accounting and unification of accounting in budget institutions and transition to a single plan of accounts for budget accounting.
